Continental Ranch Recall Information

Homeowner Russell Clanagan filed a lawsuit for preliminary injunction. He sought to have an election of new Board members conducted simultaneously with the recall process conducted at the end of January. The trial judge rejected this claim and ruled that an election of new Board members was not required by the bylaws or statute. The judge ruled that the Board appropriately conducted a recall that concerned Nicole Glasner and Tom Licht, only. The trial judge also ruled the Board acted appropriately when the Board filled the vacancies pursuant to the association bylaws.

Mr. Clanagan also sought a ruling that the Board improperly named new directors by an action in lieu of a meeting. The trial judge also rejected this claim and ruled that the Board properly filled Board vacancies via action in lieu of a meeting. The trial judge concluded the Board acted appropriately pursuant to the Association bylaws.

Mr. Clanagan also sought a ruling that new board members were improperly appointed in an open meeting. The trial judge also rejected this argument and concluded that the Board again acted appropriately when it filled two vacancies during an open meeting. The trial judge again concluded that the Board acted appropriately pursuant to the bylaws.

The trial court ruled in Mr. Clanagan' favor concerning the recount of 747 ballots that were disqualified due to a lack of signature on the envelope. The trial judge concluded that if there was a signature on the ballot, the vote should count as long as all other requirements were also fulfilled.

The original recount process required a signature on the ballot and envelope. The trial judge ruled two signatures was unnecessary. The Board had implemented this new procedure on the advice of their corporate attorney.

CONTINENTAL RANCH BOARD OF DIRECTORS MEETING RECAP, MAY 20, 2008

- The Board approved the appointment of the following homeowners, Walt Ross, Magdana Quiros, and Mary Puckett, to the Counting Committee for the court-ordered re-count of the ballots from the recall election of January 2008.
- The Board acknowledged the action-in-lieu of a meeting to allow Southern Arizona Paving and Construction to utilize the Association's property behind the community center for equipment parking and staging for the Rivulet Street repairs.
- The Board announced the new website is in place and the new address: crcatucson.com.
- The Board acknowledged the Finance Committee minutes of May 14, 2008.
- The Board approved a recommendation from the Finance Committee to waive all fines pertaining to a homeowner's account and collection costs be paid by the Association due an error in sending the account to collections.
- The Board approved the recommendation from the Finance Committee to waive a \$36 NFS fee from a homeowner's account provided that the homeowner pays his November 2007 assessment.
- The Board approved the Annual Meeting schedule provided by management.
- The Board approved management to purchase two time clocks for the pool monitors at a cost not to exceed \$1000.
- The Board acknowledged the Pool Committee minutes of May 12, 2008.
- The Board approved the recommendation from the Pool Committee to allow Northwest Fire Department to utilize Windmill Park Pool for six to eight members for approximately three hours a day for three days in preparation of their monsoon water rescue training.
- The Board approved the recommendation from the Pool Committee to accept the proposal from Meadows Pools to re-plaster the tot pool at the community center at a cost not to exceed \$4,100.
- The Board approved the recommendation from the Pool Committee to accept adding decorative tile to the tot pool during the resurfacing. Four small turtles will be added a cost no to exceed \$240 and four large turtles will be added a cost not to exceed \$1.040.
- The Board approved the recommendation from the Pool Committee to accept Saguaro Swim School to teach swim lessons and water aerobics to residents only of all ages at both community pools.
- The Board approved the recommendation from the Pool Committee to appoint Kermit McCutchen as the temporary Chair of the Committee for the months of June and July.
- The Board acknowledged the Landscape Committee minutes of May 6, 2008.
- The Board approved the recommendation from the Landscape Committee to cap-off irrigation and place screen gravel after the oleander has been removed at Coachline and Twin Peaks. The cost is not to exceed \$1,700.
- The Board approved the recommendation from the Landscape Committee to install desert landscaping in the amount not to exceed \$1,455 for area two of Lees Ferry Court (the small common area).
- The Board postponed action regarding the recommendation from the Landscape Committee to install desert landscaping at a large corner common area at Idlewild and Longrcreek in the budgeted amount of \$2,700.
- The Board approved the recommendation from the Landscape Committee to install desert landscaping on both sides, middle island and areas a long/around the washes-including irrigation

- to all plantings, replacement of two valves, battery operated timers and 1700 lin. Ft 3/4 of poly line in the budgeted amount not to exceed \$12,900 at the Marbella II entryway.
- The Board acknowledged the Covenants Committee minutes of May 13, 2008.
- The Board approved the recommended fines noted in the min-
- The Board approved the recommendation to accept Jeff Penwell as Chair of the Covenants Committee and Angela Waggner-Gabbard as Co-chair of the Covenants Committee.
- The Board approved the recommendation to appoint Chuck Stead and Marilyn Vollbrect to the Covenants Committee.
- The Board approved the recommendation from the Covenants Committee to hire The Groundskeepers to clean up the yards of those homeowners who have been given the required six notices from management and have not responded, the cost will be added to the homeowners account.
- The Board approved the recommendation from Covenants Committee to have 100 door tags printed and made that notify homeowners that due to their negligence a company will be on their lot cleaning it up.
- The Board postponed action regarding the recommendation from the Covenants Committee to approve two additional employees for site tours until they received more information.
- The Board acknowledged the ARC minutes of May 14, 2008.
- The Board approved the recommendation from the ARC to appoint Nancy Lambert and Donald Spross to the ARC.
- The Board acknowledged the Activities/Publicity Committee minutes of May 7, 2008.
- The Board approved the recommendation from the Activities/ Publicity Committee to hold a tween/teen pool party event to be scheduled for Saturday, July 26, 2008 at the community center at a cost not to exceed \$1,400.
- The Board approved the request from the Activities/Publicity committee to hold the Women's Pampering Night on Friday, September 12, 2008 at the community center at a cost not to exceed \$150
- The Board acknowledged the Strategic Planning minutes of May 8, 2008.
- The Board acknowledged the appointment of Tina Cloutier as the Strategic Planning Chair.
- The Board acknowledged the Facilities Committee meeting minutes of May 19, 2008.
- The Board approved the request of D'mention to purchase the four old computers from the Association in the amount of \$100 each for a total of \$400. The funds will be donated to a local not for profit organization to be determined at a later date.

- The Board approved to allow the Division of Elections to utilize the Community Center for the September 2, 2008 and the November 4, 2008 elections.

It is time for Pre-emergent

The Groundskeeper is once again offering the pre-emergent treatment for your front yards. If you would like to have a little help in controlling your weeds, you may sign up now for the pre-emergent treatment. Spraying will begin at the first start of the rains, typically the first week of July, and go through until the last week in August. The deadline for registering to have this treatment applied will be July 31st. Please take the time to fill out the registration form below, then mail it to 9150 N. Coachline Blvd. Tucson, AZ 85743 or drop it off at the Windmill Park Office. You will also need to attach a check to the registration form in the amount of \$45.00 made out to CRCA.

CAUTION: BEES



Stratford Management would like to advise all Continental Ranch residents of a serious bee problem in our community. We have had numerous reports of hives in the neighborhood. Please take a moment to walk your property in search of any bee activity or hives, which could be located either on your home or in your yard. We have seen the bees entering homes under the roof tiles, through the bird board (small holes covered with screen at the roof line), and hanging in trees.

Please share this information with your family, friends, and neighbors, in case they do not read the newsletter. Please also use caution when walking along the sidewalk. One of the hives reported was in a small mesquite tree over hanging the sidewalk.

If you do discover bees on your property, Mr. Dennis Dolan with the Town of Marana recommends Phils Bees at 1-806-241-8269. They are the most reasonable and reliable. He is in Tucson although the number is long distance.






