B. Old Business

1. 2008/2009 Budget

- a. Committee Members reviewed and discussed the current budget.
- b. **Teens and 'Tweens' Events**
 - Members agreed that getting teens involved in the community would be worth requesting additional funds for the budget. 'Teen Auction' was discussed. Suggestion was made that we look into 'Teen Auction' and reward event, but also offer other activities to all teens.
 - Suggestions for teen events included, but were not limited to: 'Diving' Movie/Pool Party, dance, back to school mixer, and movie in the park.
 - Proposed Event date for 'Diving' movie/pool party to be July 26, 2008. Event will be by RVSP and will be advertised through the newsletter, flyers, and marquee.
 - **Action:** Motion was made, seconded and unanimously passed to accept the teen event at a cost not to exceed \$1400. (DiPalma/Keller)
- c. Budget proposal of \$11,000 will move forward after adding the teen event, Management will forward to Finance.

2. Community Yard Sale

- a. Discussion took place regarding the possibility of teaming up with Sunflower for the Community Yard Sale to increase advertising and in hopes to draw a larger crowd. Management will contact Sunflower for further information.
- b. **Action:** Motion was made, seconded and unanimously carried to accept October 11, 2008 for the Community Yard Sale. (DiPalma/Keller)

3. Spring Concert

- a. Discussion was held regarding the transition between performances. Suggestion was made that we have more raffles, games, hula lessons, etc. to entertain while performers are setting up.
- b. Nicole reminded committee that sprinklers at Windmill Park need to be turned off prior to events.

C. Newsletter

1. Newsletter Design

- a. The Committee viewed samples provided by Stephanie Rising with The Next Level. The Committee discussed black and white versus colored newsletter.
- b. Lexie was asked to seek three (3) bids for printing costs, both black and white and color.

2. Current pricing with Alphographics

- a. Lexie will find out a breakdown of cost from Alphographics for monthly newsletter.

3. Suggestions for June Newsletter

- a. Goldenrod insert with Book Exchange, Scrapbooking Event, and 'Tween'/Teen Night, put committee updates before board recap, look into doing a calendar insert, rather than an actual page and putting in a year recap with pictures from events. Committee article will include upcoming events and a recap of the Spring Concert.
