Call to Order and Establish Quorum:

Approval of Minutes:

ACTION: A motion was made, seconded and unanimously carried to approve the October 6, 2008 Meeting Minutes. (R. Singervalt/M. Philips)

OLD BUSINESS:

A. Halloween Event

The Committee discussed the October 25th event. Members agreed that the event should be held from 4 to 6 PM next year.

NEW BUSINESS:

A. Fall Festival

The Committee discussed last minute details for the November 8th event. All vendors have been contacted and confirmed. The Town of Marana will bag "No Parking" signs for the event. B. Holiday Decoration Contest

G. Other
