President's Report

After receiving responses to the Request for Proposals (RFP) in December of 2009, the Landscape Committee and BOD spent a lot of time reviewing each proposal and narrowing the field to the four companies they felt were up to doing common area landscape maintenance for CRCA. There were onsite tours made of the four selected bidders' reference properties and all four companies were invited to do a 15 minute presentation at the March 10th study session. The BOD unanimously selected DLC Resources to take over the maintenance contract on April 18, 2010. We would like to thank The Groundskeeper for their past service to CRCA and welcome DLC as our new landscaper.

The office, as well as myself, have fielded numerous complaints about the weeds and rodent holes along Silverbell road. CRCA does not own the property behind the sidewalk to the wall along Silverbell Road- this is public right of way owned by the Town of Marana and as such is their responsibility.

The Northwest YMCA approached me about providing programs within CRCA for our residents. We are partnering with the YMCA in an attempt to bring more activities to our members. There will be an Open House at the Community Center on Sunday, April 25th from 1PM to 4PM with staff from the YMCA present to provide information on possible programs that will be ►

Through policies and actions adopted and enacted by past BOD's and management companies we have had to readdress a large number of issues, both legally and financially. The entry way to the offices will be undergoing removal and replacement because of liability issues with the current condition of the concrete walkway. The Windmill pool fence will require unplanned replacement because of rust issues not properly addressed in the past. This BOD inherited a mess and has diligently worked to make CRCA a better community while meeting our "fiduciary duty" to the Corporation. I appreciate the commitment of the current Board and Committee members and the time they give to our Association. Rest assured we will diligently follow through on our promises to the community.

Health Tips


- Become interested and educate yourself in what you are eating.

RESOLUTION

OF THE BOARD OF DIRECTORS

OF THE CONTINENTAL RANCH COMMUNITY ASSOCIATION

Whereas, the Board of Directors of the Continental Ranch Community Association, Inc. is empowered to govern the affairs of the Homeowners Association pursuant to Article V, Section 2.7 of the Bylaws, and;

Whereas, there is a need to clarify the Association's position on street parking.

Whereas, it is the intent that this rule shall be applicable to all Owners and tenants and this resolution shall remain in effect until otherwise rescinded, modified, or amended by a majority of the Board of Directors,

NOW, THEREFORE, IT IS RESOLVED THAT the Board of Directors decrees that the Continental Ranch Community Association's Covenants, Conditions and Restrictions ("CC&Rs") provide that there shall be no parking on streets within Continental Ranch. Some owners believe that the CC&Rs parking prohibitions should not be enforced because 1) the streets were dedicated to the public, and 2) there is no ordinance against street parking in the Town of Marana. The CC&Rs are recorded deed restrictions that constitute a contract between CRCA and each homeowner. Accordingly, the Board is contractually obligated to enforce the CC&R parking prohibitions against offending homeowners. Arizona law requires that all enforcement actions must be reasonable. Wherefore, the Board has adopted over the years a reasonable policy to enforce the CC&Rs. By adoption of this resolution, the Board is ratifying the parking policy used for over ten (10) years as follows:

- All street parking must be called into the association or emailed to relieve a non-compliance infraction;
- A parking variance can be issued through the Association Office for contractor parking, social events, family emergencies or any other unforeseen event. Medical variances can be issued;



March Recap: Board Meeting

The following are highlights from the regular meeting of the Board of Directors held March 17, 2010 at the Community Center. Completed minutes are posted to the website in draft format and will be approved at the next regular meeting in April. A copy may also be requested from the office staff.

Consent Agenda Approvals

Receipt of committee minutes was acknowledged. Lowering of temperature in the Windmill Park pool authorized. Drain Windmill Park pool spa monthly as part of routine cleaning. Repairs to spillway at Marbella II entryway authorized. Transfer of funds from Stratford Operating Account. Investment of roll-over CD funds at Washington Federal in local bank offering higher rate. The resignation of Ms. Verna Keller from Activities Committee accepted with regret. New committee appointments: Mr. Richard Singervalt as Chair of Activities Committee for April and May 2010, and appointments of Mrs. Sandy Padilla and Mrs. Carol Altmann to Finance Committee approved.

Board Approval

Rescind the resolution regarding the handling of bank statements by Stratford Management. Proposal of Stewart Paving to renovate the Windmill Park entry by concrete removal and installation of brick pavers. Revise operating hours for Windmill Park pool, to close at 8 p.m. until pool monitors are hired. Approval to hire Saguaro Pool Inc. for repairs at Community Center pool. Contract to replace a section of fence at the Community Center pool awarded to Antech. Minor repairs to the kiddy pool shade structure to remove rust and tighten tarp cable will also be done. Authorization to reposition security cameras. Opening of Community Center pool contingent on completion of repairs in progress. Hire nine pool monitors and three monitor supervisors to begin duty

on 1 May through 7 September. Replace polybutylene pipe in Community Center by Plumb Plumbing. Air conditioning unit repairs at both Community Center and Windmill Park complex awarded to D&H. Landscape contract to be awarded to DLC Resources pending lesser-cost negotiations. If not successful, contract will be awarded to Complete Landscaping. Summer swimming program for children awarded to Saguaro; summer youth and adult activities programs sponsored by the YMCA to be presented at open house scheduled for 25 April, and later presented for Board approval. Street parking policy resolution finalized and will be included in current mailing to homeowners, as required. Fees waived for new contract with Little League and Soccer.

Board Consideration

Possible landscaping upgrades in area of Twin Peaks east, at point of interchange connection project, with boundaries to be discussed first with the Town of Marana. Input to be requested from new landscape contractor and homeowners.

Manager's Report

Reserve Study report will be made available as soon as received. New codes to be assigned to help with the budgeting process. New member to the office staff welcomed: Mr. Kyle Nickell, replacing Mr. Bill Heady who resigned in early March. Winter rains have brought forth a bevy of weeds and wild flowers. Pre-emergent for individual homeowners available now from Groundskeeper. In the office, VMS is up and working 100%. Covenants Committee and management reviewed the sequencing of violation letters. Interviews for positions of pool monitors and supervisors will begin in late March. Those selected will attend mandatory training by the Pima County Health Department in April.

Tips For Spring Planting . . .

Warm weather is just down the road, and homeowners' thoughts will be turning to all things green. Now would be a good time to go over what's OK to plant and what isn't. What isn't is listed in the back of the New Design Guidelines on the CRCA website. Low water use plants are not a requirement—they're a good idea, but the decision is up to you.

When selecting new plants for your spring/summer planting, it might be a good idea to take the Prohibited Plant List with you to the nursery to be sure you're not getting something that's on the list. The list contains both the common name and the botanical name. Just

to clear up any confusion, the Prohibited Plant List applies to the front yard only.

If you're looking for a suggested landscape plant list, try the "Arizona Department of Water Resources—Drought Tolerant / Low Water Use Plant List." That list can be found at www.azwater.gov. In the search window, type in "low water."

Planting in your backyard does not require you to submit an approval form. However, planting in your front yard does. This serves as a double check on the prohibited plant list, protects you, and gives the CRCA a record of what was done and when. Just good common sense!

Pool Committee

Summer is just around the corner, and temperatures are beginning to rise as we break through the unusually wet spring. The Pool Committee has been heavily deliberating over settling a few topics in time for the 2010 Summer Season.



The Community Center pool will open a little later than planned this year due to repairs that need to be made, which were delayed by the temperamental weather. This 'N That...

With Easter early in April, it's a good time to walk around Felix Lucero Park—the tiny respite just off I-10 and Broadway in downtown Tucson—in order to reflect on the Christian teachings of the apostles at the Last Supper and the crucifixion as sculpted in concrete by Felix Lucero in the 1940's. Mr. Lucero's original statues were washed away by a flood, but he re-created his pieces in order to fulfill a personal promise made during World War I on the battlefields of France. The statues have been moved several times due to road construction and flood control measures, and some have been damaged by vandals. However, they have endured these past 60 years and now appear to have a permanent home in the quiet setting just off the busy freeway, inhabited only by chirping birds and a few squirrels and surrounded by trees and ground foliage, blocking out the street noises.

The winter rains have enticed lovely wildflowers to poke their heads out and bring us a bit of joy! Take time to enjoy them—it's worth the time to drive to outlying areas and witness the glory of the

season in all its happy array of color! The hikers are reporting beautiful patches of color as they enjoy the trails.


