President's Report -John Lambert

I reported in last month's newsletter that the shade structure at the community center pool was never designed for usage in a pool area, that corrosion had occurred because of exposure to water resulting in it being unsafe and that the BOD made it a priority item to replace it ASAP. Management went right to work on investigating the replacement and I am sorry to say that this project will take longer to complete than we had hoped. Between engineers designing it, permitting required by the Town of Marana, and the 6 to 8 weeks to build it, we were informed that the replacement of the shade would take until at least October. The BOD decided to wait until the pool is closed and to perform the work then. The BOD did approve relocating the existing shade structure to the Mountain Sky pocket park.

We were able to move forward with a few other projects that have been under consideration for some time. The security lights as well as the parking lot lights at the community center will be replaced with low energy usage LED bulbs. We are anticipating our electric bill for just replacing the parking lot lights with LED's will be reduced from a monthly cost of around \$450 down to under \$40 a month. It is safely projected that we will receive back our full investment in this project in 5 years with energy savings. If TEP reinstates their utility rebate program we will be eligible for a rebate of \$3670.00 as well.

President's Report Continued...

Access to the Windmill Park Ramada's and the park itself will be enhanced for the handicapped as well as all residents by the continuation of the brick walkway from the office to the ramadas. A culvert will be installed with a raised walkway over the drainage swale in the grass making this fully accessible to all residents and the area between and around the ramadas will be bricked. It should be a great improvement to our community.

As most of you are aware CRCA has had numerous incidences of vandalism and trespass after hours. A number of monument lights were destroyed with rocks smashing the cages and lights recently. The BOD approved replacing the lights with a different fixture in hopes of stopping this type of vandalism. The BOD also approved upgrading of the security cameras at the community center as well.

All of these projects are within budget and will add great benefit to this community as well as future cost savings. This BOD has been able to complete a large number of projects that have enhanced CRCA with no dues increase required. The finance committee will be preparing next year's budget to present to the BOD-hopefully they will present a proposed budget that sees no increase in dues or cuts to existing goals.

Pool Key Cards

Continental Ranch currently uses electronic key cards. The benefit of these key cards is the ability to deactivate them when they are reported lost.



Over the past few months, and for the next few months, these key cards will be researched in hopes of cleaning up the records. Unidentified keys will be deactivated. If you notice your key is not working, please contact the CRCA office so the card can be properly updated.

June Recap: Meeting At A Glance

The following are highlights from the regular meeting of the Board of Directors held 21 June 2012 at the Community Center. Completed minutes are posted to the web site in draft format and will be approved at the next appropriate meeting. A copy may also be requested from the office staff.

Homeowner Forum

1. A concern regarding a petition was addressed. 2. A resident spoke about saving the Sycamore trees and suggested consultation with an independent arborist. 3. A resident requested financial consideration and an attempt to conform to standards of the community.

Recent Correspondence

1. A resident requested amendment to previous minutes. 2. A request to use the pool for swimming lessons denied. 3. A thank you from Brownie Girl Scouts, Troop 320. 4. A request to post an A-frame sign by Saguaro Aquatics denied. 5. Appreciation for correcting a pool key situation.

Board Actions

Approval given to contribute \$800.00 to help sponsor the Marana Concert scheduled for 8 September 2012. An Activities Committee checklist was approved. The shade canopy at the Community Center kiddie pool to be moved to Mountain Sky Pocket Park immediately, and construction of a new canopy at the kiddie pool postponed until the pool is closed for the season. Proposal of Oasis Pool Service, Tucson approved to repair/replace the Windmill spa filter tank. DLC authorized to proceed with soil stabilization with calcium chloride at the Windmill basin slope. Pool key card system data as prepared by staff appreciated, and authorization to proceed with accountability and identification efforts given. New pool key replacement fees authorized. Several fines and clean-up recommendations made by the Covenants Committee were approved. Financial reports for May 2012 were approved. Finance Committee's request to move meeting day approved. Approval given to hire HBL Hammel, Beal and Lauer PC, Tucson to tally and record votes at the next annual election. Parcel 17 wall painting recommendations were approved under the Consent Agenda.

Approval given to install a continuing brick path at Windmill Park for better access to the ramadas, to include installation, irrigation modification, hand railing, and additional brickwork in front of the office. Approval given to Relumination to upgrade to LED lighting around the pool and parking lot of the Community Center. Guard Pro's proposal to install five 1.3 megapixel cameras at the Community Center was approved. Sovereign Electric authorized to replace vandalism-damaged monument sign lighting at Silverbell/Coachline, and replace monument sign lighting at Silverbell/Wade. Action postponed on installation of new electrical lines to breakers for both pools.

Manager's Report

Vandalism with turf damage noted. Pool fence "hopping" and light bulb vandalism on two occasions discussed. Landscaping/grass concerns and Windmill Park needing improvement were noted. Management had a meeting with Town of Marana personnel to discuss lighting issues. Sixty-three residents in assessment arrears of \$327.00 or more will receive a letter.

Residents discussed Center cleanliness issues with a reminder to contact the office when infractions are noted. All service contracts to be reviewed and will include the addition of indemnification clauses. Sunday church unloading and reloading equipment issues to be discussed with the Center renters. A pool committee member indicated appreciation for pool upgrading efforts being authorized by the Board.

What is a Board of Directors

"Executive Session"?

Anyone who tunes in to the Associations Board of Directors functions might notice that each month there is an "Executive Session" which takes place following the regular Board Meeting. You might be curious as to what might be discussed behind closed doors.

The private "Executive Session" meetings are held in accordance with state laws which require certain topics be discussed privately. There are specific factors that dictate whether a topic is something that must be discussed publicly in an open meeting, or whether it must be discussed privately in Executive Session.



Here are the topics that should be held in Executive Session so as to protect sensitive and confidential information of the members:

- 1. Legal advice from an attorney for the board or the association. On final resolution of any matter for which the board received legal advice or that concerned pending or contemplated litigation, the board may disclose information about that matter in an open meeting except for matters that are required to remain confidential by the terms of a settlement agreement or judgment.
- 2. Pending or contemplated litigation.
- 3. Personal, health or financial information about an individual member of the association, an individual employee of the association or an individual employee of a contractor for the association, including records of the association directly related to the personal, health or financial information about an individual member of the association, an individual employee of the association or an individual employee of a contractor for the association.
- 4. Matters relating to the job performance of, compensation of, health records of or specific complaints against an individual employee of the association or an individual employee of a contractor of the association who works under the direction of the association.
- 5. Discussion of a member's appeal of any violation cited or penalty imposed by the association except on request of the affected member that the meeting be held in an open session.

Your CRCA Board of directors strives to be fully compliant with the Planned Communities Act, Open Meeting Law, Arizona Revised Statues, and any other pertinent case law as advised by legal counsel. If a topic belongs in open meeting – that is always where it is held. If a topic should be discussed in Executive Session, the Board follows good practices and meets about it in Executive Session.

Trash Forum Recap

Hopefully you made it to the open forum last month, but if you missed it – here's the recap.

In preparation for the October 2012 termination of the 5-year exclusive contract with Waste Management, a community forum was held for Continental Ranch at the Twin Peaks Elementary Saturday afternoon on June 23rd. Trash service providers were invited to attend and present their proposals in hopes of being named as the upcoming "preferred provider" for servicing Continental Ranch. CRCA Management contacted 6 different service providers in the Tucson area, and of the contacts made, Right Away Disposal (RAD) and Waste Management (WM) attended.



No actual decisions were made at the forum, but many questions were asked to the trash companies by the audience members. The Board President, John

Lambert, explained that the current Board of Directors had approved a resolution to not enter into any future exclusive contracts. A "preferred provider" would be considered in the hopes of negotiating the "best deal for the community", however, even if a preferred provider is named – residents will have the free choice to select any company that they wish to.

If you're interested in hearing more discussion on the selection of the trash service provider, keep an eye out for future topics on the Board of Directors monthly meeting agendas. The agendas are posted approximately one week prior to the meetings, and meetings are held at the CRCA Community Center the third Thursday of each month (please see pages 12 & 13 of the newsletter for the full calendar of CRCA events).






