Item A: Accept recommendation to replace three backflow insulators, one located at Parcel 42 and two located at Windmill Park, by Titan Landscape at a cost not to exceed \$635.00.

Item B: Recording of Action in Lieu, undated, for approval of two proposals from Titan Landscape for the installation of new turf and concrete edging at the Parcel 26 Pocket Park, at costs not to exceed \$2,389.69 and \$801.42, respectively.

Item C:—Accept proposal from Titan Landscape for landscape enhancements of the Windmill Park west parking lot area to include irrigation, eight 24" box Swan Hill Olive trees, and top dress with granite decorative rock at a cost of \$11,513.00.
