Continental Ranch is well known for its wonderful parks and fields throughout the community, especially Windmill Park near Twin Peaks Road and Coachline Boulevard. The Association strives to keep the fields in top condition for residents' enjoyment year-round. These fields are also a great place for various youth sports leagues to hold their weekly tean

The Association welcomes local teams to make use of the fields, with the simple requirement that they first get approved by the CRCA management office. There are a couple basic requirements for teams to qualify, such as submitting a proof of the team's insurance coverage and player roster.

Coaches are encouraged to contact the CRCA office at 520-297-7600 in advance to get approval and reserve a time for their team to use one of the fields. Teams must obtain approval prior to conducting practice. The CRCA management staff is happy to help with any questions you may have related to sports team use of the park and hopes the leagues will take advantage of these fantastic amenities.



First, we would like to welcome back the cooler weather and our winter residents and visitors! As everyone takes advantage of our beautiful climate this time of year, I am fairly confident of several things:

- 1. Black Friday sales will start before many have even sat down for Thanksgiving dinner;
- 2. The Holiday Festival will occur the first Saturday in December;
- 3. There will be an increase in cars on the roads and pedestrians on the sidewalks, and;
- 4. There will be more activities in the parks and yard sales in the neighborhoods.

To support everyone's safety and enjoyment, I would like to remind you to be careful and follow the laws and local ordinances. Specifically, as they relate to yard sales, parking and being in public with your dogs.

While it is permissible to place yard sale signs, they are not allowed to be placed in the medians, on sidewalks, on regulatory signs, on utility poles, or in any location which may obstruct visibility. Also, if you place yard sale signs, it is your responsibility to pick them up at the conclusion of the sale.

With regards to parking, please remember that recreational vehicles and trailers are not permitted to be parked on residential streets for over 72 hours. This time period was set to accommodate the packing/ unpacking & clean-up for a trip or to allow for the occasional visitor, while recognizing that the size of these vehicles can impact both movement and visibility. Therefore, please be mindful of the time allotted and exercise caution while moving around these vehicles.

Finally, while we encourage all pet owners to spend time with their pets and to provide for exercise, both state law and Marana Town Code require that all dogs be leashed and under physical control of their owner/ handler while in public. The only exception to this is while a dog is inside one of the numerous fenced & designated dog parks around town. These laws are designed to protect both the public and your pets, so we would appreciate everyone's cooperation with these requirements.

Have a safe and happy holiday season and be sure to take advantage of some of the wonderful activities around town this time of year!

Dog Poop Doesn't Biodegrade Like Wild Animal Poop

We feed our dogs food that's very different from the food wild animals eat, therefore, dog waste does not biodegrade quickly like wild animal waste. Because of the sheer number of pets in suburban neighborhoods and in local parks, this hardy dog waste accumulates.

② Dog Poop Contains Harmful Bacteria, Parasites. Dog waste can contain harmful organisms like E. coli, giardia, salmonella, roundworms,

hookworms, and cryptosporidium. These can be passed on to you or your pet, and may cause health problems.

Waste Management Tips for Safe Service

Safety is a core value at Waste Management. We are focused on delivering the safest, most reliable service to your home every week. Here are some tips for helping keep your neighborhood clean and green.

Select a Safe Pickup Spot

Follow these easy guidelines to ensure your trash or recycling cart can be successfully serviced every time. When placing your cart on the street, please ensure:

- Cart is 4 feet from any other object, including mailboxes, parked cars, fences, overhead power lines and other carts. Trucks need a safe space to access, lift and empty the cart.
- Handle faces the house or sidewalk, not the street. This helps the lid to open correctly during servicing, so materials fall into the truck, rather than the street.
- All materials fit inside the cart with the lid closed. This reduces the chance of materials falling out on the street while being emptied.

Missed Pickup?

While we have a 99.9% success rate for collection, on rare occasions we may miss a home. If your cart is not serviced on your regular collection day, please call 800-796-9696 to report the missed pickup. We typically return the next day so be sure to put your cart out the next morning by 6:00AM for service

Stay Safe around Trucks

We love to see kids smile and wave when we drive through the neighborhood and service your home! As the weather warms up, please remind children to watch our operations safely from your front yard. They should never attempt to touch a working truck or add anything to a cart while it's being serviced

- Maintain a safe zone. Stay at least 15 feet from a truck while it is servicing your cart.
- ٠ If a pet runs under a truck while it is servicing your cart, do not chase it. Get the driver's attention and approach the truck to retrieve your pet when the driver indicates it is safe.

Eliminate Fire Hazards

Products that contain flammable, corrosive, toxic, or poisonous ingredients are considered hazardous and should NOT be disposed in your curbside cart. Examples include oil, paint, chemicals, batteries, fluorescent lamps and propane tanks

Flammable materials can ignite in your trash cart or in the truck and cause dangerous fires. Oil, paint and other toxic fluids can leak out of the truck, stain the streets and contaminate storm systems

Please check with the city or county for information on where to properly and legally dispose of any hazardous items





FREE YOUR RECYCLABLES.

Due to global changes in the recycling industry and commodity markets, collecting quality recyclable materials is more important than ever. Waste Management needs your help to reduce recycling contamination. To launch this initiative, we are focusing on one of the biggest contaminants - bagged recyclables. We are asking customers to "LOOSE LOAD" their recycling.

Don't Bag Recyclables - Place items directly in recycling container.

What is the Problem and Why Does it Matter?

Plastic bags add another step to recycling: Breaking open bags containing recyclable materials requires additional labor, slows down the recycling process and increases the cost of recycling

Plastic bags interfere with machinery: Plastic bags get wrapped around the equipment, requiring us to shut down the recycling process several times a day. Workers are then required to climb into the machinery and cut plastic bags out of gears and screens. This poses a safety threat to workers and increases the cost of recycling. (see the flip side for steps you can take.)



RECYCLE OFTE RECYCLE RIGH

What Can You Do?

"Loose Load" your recycling! Here's how:

- 1) If needed, use only plastic liners for smaller recycling bins typically used inside your facility in offices or for breakroom recycling.
- 2) Check the liners for food or liquid contamination before you add the recyclable materials to the recycling dumpster. If the liners contain food or liquid, they are contaminated. Cinch these bags and place in the trash.
- 3) If recyclable materials in the liner are clean and dry, leave the bag untied and take it to the dumpster.
- 4) At the recycling dumpster, empty the recyclable materials directly into the container. Reuse, take back to accepting local retailers, or dispose of the liner in the trash.

Let's all get back to the basics of good recycling and remember these three rules each time you toss something into your recycling container:



cans, paper and cardboard.





Empty recyclables directly into your recycling container - NO bagged recyclables.
